DVHL Applicable Bylaws:

D. Definition of Levels

1. AA Division

- a) Must have a minimum of six (6) teams
- b) Will consist of the strongest teams at each age level
- c) Will consist of teams from an organization who has three or more teams on a level
- d) Will consist of teams from an organization who has two or less teams on a level who has scored 70% or higher in their combined percentages from the prior season. (Combined percentages will be construed by the percentage of the level being declared with the percentage of the level beneath it.)
- e) Clubs that have 3 teams at a level or who has scored 70% or higher in their combined percentages, may petition to participate in the "A" Division, but will forfeit their league championship and post season eligibility. If as a result of petitioning, a club has more than one team at a level, the team with the better record will forfeit their league championship and post season eligibility.
- f) Will advance to Districts (Southern teams not included). Southern teams are included in competition for the League title wherever applicable

EXCEPTION: A petitioned "B" team from the previous year, scoring 70% or better in the previous season, will not be subject to being required to play at the "AA" level if that team is the only team in the club at that level and will be permitted to skate at the "A" level without prejudice and will be able to qualify for the league playoffs and championship.

2. A Division

- a) Will consist of remaining teams.
- b) It is at the discretion of the Executive Committee to move a team from the A division to the AA division.

3. B Division

- a) Will consist of teams from organizations that already have AA or A teams on that level.
- b) Clubs that have 1 team at a level may petition to participate in the "B" Division, but will forfeit their league championship and post season eligibility. If as a result of petitioning, a club has more than one team at a level, the team with the better record will forfeit their league championship and post season eligibility.

4. C Division

See DVHL Bylaws

The petitioning meeting of the Executive Committee must be completed prior to the schedulers meeting.

I, _____, an authorized representative for the above team, accept full responsibility for this petitioning. I am aware that if this petition is granted, the above team will not be eligible to win the DVHL League Championship or advance to the DVHL Playoffs, the Atlantic District Tournaments or USA Hockey Nationals.

I further agree and acknowledge that the "Roster" submitted in support of this petition is "frozen" for the upcoming season unless additions are approved by the appropriate board member.

I acknowledge that both the parents and players are aware that a team granted their petition is not eligible for the DVHL League Championship nor can they participate in either the DVHL or Atlantic District Playoffs or Tournaments.
